REPORTS - POLICE DEPARTMENT

Police Department reported that the department traveled 5265 miles during April 2018; responded to 585 non-dispatched calls; 246 dispatched calls; 3 officer assists, and assisted the fire department 0 times. Besides all of this, 139 citations, 8 warnings. Worked 58 cases, 14 misdemeanor arrests and 9 felony arrest were made.

FIRE DEPARTMENT

Fire Department reported that the Fire Department responded to 61 calls for assistance during April 2018. 44 medical calls, 1 structure fire, 0 grass fires, 0 vehicle fires, 3 motor vehicle accidents, 3 lake rescues, 1 landing zone, 1 hazmat call, 8 assist calls and 0 mutual-aide calls, totaling 57 volunteer man hours.

FIRE MARSHAL REPORT (BUILDING INSPECTOR/CODE ENFORCEMENT)

<u>Building Inspector</u>- During the month of April 2018, 9 building permits were issued. There were 12 building inspections performed. Total permit fees collected were **\$110.00**. The total added value to the city was **\$31,600** for a total year to date of **\$1,936,170**.

<u>Code Enforcement</u> – During the month of April there were 7 warnings issued. Started 3 new code violation cases and 11 properties voluntarily came into compliance.

<u>Fire Marshal</u> – There was 0 fire investigations for the month of April. The Fire Marshal's office assisted Onalaska PD 5 times and OVFD 1 time.

<u>Park Report/Pavilion Use</u> – Preparing for our next Market Days Event to be held on July $6-8^{th}$.
