Quorum being present, Patsy Goins absence was excused, the Mayor continued with the meeting. The purpose of the meeting was to hear from the public, approve the consent agenda (minutes, voucher list and accept the financial report), hear reports from the departments, review and approve the Onalaska Police Department 2017 Racial Profile Report, accept the resignation of Police Officer Troy Vaughn from full time status and approve Officer Troy Vaughn to continue to serve as a Reserve Police Officer, review and approve Anthony Whitten to serve as full-time Police Officer with the standard 6 month probationary period, review and approve preliminary plat submission, executive (Closed) session in accordance with GC 551.074 Personnel Matters, review and approve budget amendment for salary adjustment for one or more employees and announce any other upcoming events.

CONSENT AGENDA

REPORTS – POLICE DEPARTMENT

Police Department reported that the department traveled 3528 miles during January 2018; responded to 815 non-dispatched calls; 123 dispatched calls; 11 officer assists, and assisted the fire department 2 times. Besides all of this, 99 citations, 12 warnings. Worked 29 cases, 18 misdemeanor arrests and 0 felony arrest were made.

FIRE DEPARTMENT

Fire Department reported that the Fire Department responded to 52 calls for assistance during January 2018. 36 medical calls, 4 structure fires, 6 grass fires, 0 vehicle fires, 2 motor vehicle accidents, 2 lake rescues, 0 landing zones, 0 hazmat calls, 2 assist calls and 0 mutual-aide calls, totaling 198 volunteer man hours.

FIRE MARSHAL REPORT (BUILDING INSPECTOR/CODE ENFORCEMENT)

<u>Building Inspector</u>- During the month of January 2018, 11 building permits were issued. There were 16 building inspections performed. Total permit fees collected were **\$2118.00**. The total added value to the city was **\$409,800** for a total year to date of **\$931,220**.

<u>Code Enforcement</u> – During the month of January there were 8 charges filed for various Health and Safety Code Violations and one arrest for illegal burn.

<u>Fire Marshal</u> – There was one assisted fire investigation outside of the city during the month of January. The Fire Marshal's office assisted Onalaska PD 7 times, OVFD 2 time and PCSO 1 time.

<u>Park Report/Pavilion Use</u> – Roy Newport advised the RV Connection has been installed at the park for Market Days.
