Police Department reported that the department traveled 3930 miles during March 2021; 364 Subdivision Patrols, 44 Business Checks, 398 Calls for Service, 13 Felony Arrests, 11 Misdemeanor Arrests, 137 Citations, 124 Warnings, Assisted PCSO 26 times, Assisted DPS 3 times and Assisted OVFD/EMS 11 times, 43 New Cases, 2 Narcotic/DWI Arrests and 7 Warrants Cleared.

CODE ENFORCEMENT/PERMITING

<u>Building Inspector</u>- During March 2021, 12 permits were issued. Total permit fees collected were **\$3,642.70** The total added value to the city was **\$552,500**.

Code Enforcement –There were 9 Ordinance warnings issued in March. Out of three properties previously warned 2 are working toward compliance and 1 came into compliance. Currently there are two properties in the abatement process and will be presented to council at a later date if compliance is not achieved.
