Quorum being present, Kevin Arnett arrived 5:10 p.m., the Mayor continued with the meeting. <u>REPORTS - POLICE DEPARTMENT</u>

Police Department reported that the department traveled 4991.1 miles during August 2022; 348 Subdivision Patrols, 88 Business Checks, 734 Calls for Service, 13 Arrests, 107 Citations, 145 Warnings, Other Agency Assist 15 times and Assisted OVFD/EMS 16 times, 50 Cases and 9 Warrants worked.

FIRE DEPARTMENT

Fire Department reported that the Fire Department responded to 70 calls for assistance during August 2022. 34 medical calls, 2 structure fires, 19 grass fires, 0 vehicle fires, 3 motor vehicle accidents, 4 lake rescue, 2 landing zone calls, 1 hazmat call, 2 assist calls and 3 mutual-aide calls, totaling 122 volunteer man hours.

CODE ENFORCEMENT/PERMITING

There were 17 permits issued and 16 inspections performed in the month of August. Total collected was \$4,374.20.

FIRE INVESTIGATIONS

There were 9 warning issued for burn ban violations during August. There was one fire investigation during the burn ban that consisted of household trash being burned.
