REPORTS - POLICE DEPARTMENT

Police Department reported that the department traveled 4464.5 miles during September 2022; 398 Subdivision Patrols, 81 Business Checks, 857 Calls for Service, 25 Arrests, 91 Citations, 131 Warnings, Other Agency Assist 12 times and Assisted OVFD/EMS 7 times, 25 Cases and 24 Warrants worked.

FIRE DEPARTMENT

Fire Department reported that the Fire Department responded to 53 calls for assistance during September 2022. 36 medical calls, 5 structure fires, 6 grass fires, 0 vehicle fires, 1 motor vehicle accident, 1 lake rescue, 2 landing zone calls, 0 hazmat calls, 2 assist calls and 0 mutual-aide calls, totaling 147 volunteer man hours.

CODE ENFORCEMENT/PERMITING

There were 10 permits issued and 17 inspections performed in the month of September. Total collected was \$3,673.10.

FIRE INVESTIGATIONS

There were 3 false alarms responded to during September 2022. All 3 were due to false reports of unattended "control burns" at the same location.
