REPORTS - POLICE DEPARTMENT

Police Department reported that the department traveled 3402.4 miles during October 2022; 393 Subdivision Patrols, 64 Business Checks, 840 Calls for Service, 12 Arrests, 111 Citations, 184 Warnings, Other Agency Assist 28 times and Assisted OVFD/EMS 11 times, 33 Cases and 8 Warrants worked.

FIRE DEPARTMENT

Fire Department reported that the Fire Department responded to 66 calls for assistance during October 2022. 31 medical calls, 5 structure fires, 25 grass fires, 0 vehicle fires, 5 motor vehicle accidents, 3 lake rescues, 3 landing zone calls, 0 hazmat calls, 4 assist calls and 2 mutual-aide calls, totaling 107 volunteer man hours.

CODE ENFORCEMENT/PERMITING

There were 14 permits issued in the month of October. Total collected was \$3,440.60.

FIRE INVESTIGATIONS

There was 1 fire investigation done during October. The Fire Marshal's Office responded to 4 Burn Ban Violations, assisted OPD 4 times, Onalaska VFD 4 times and Polk County Fire Marshal's office 1 time.
