Quorum being present, the Mayor continued with the meeting. The purpose of the meeting was to hear from the public, approve the consent agenda minutes, voucher list and accept the financial report, hear reports from the departments, motion to approve Ordinance 438 Budget Amendments to Ordinance 412 FY 2021-2022 Annual Budget, presentation of FY 2021-2022 Annual Audit by Darla Dear with Belt Harris Pechacek, LLLP of Houston, motion to accept FY 2021-2022 Annual Audit performed by Belt Harris Pechacek, LLLP of Houston as presented, accept the resignation of Police Officer Bailey Deaton, in good standing, accept the resignation of Telecommunications Operator Adron Seward, in good standing, motion to accept the 2022 Racial Profile report as presented, review and authorize the Mayor to sign a modification to the Waste Collection Service Contract authorizing an increase in rates not to exceed 10% effective May 1, 2023 due to increasing cost of service and announce any other upcoming events.

REPORTS - POLICE DEPARTMENT

Police Department reported that the department traveled 3875 miles during January 2023; 376 Subdivision Patrols, 99 Business Checks, 465 Calls for Service, 18 Arrests, 85 Citations, 141 Warnings, Other Agency Assist 16 times and Assisted OVFD/EMS 5 times, 20 Cases and 13 Warrants served.

FIRE DEPARTMENT

Fire Department reported that the Fire Department responded to 66 calls for assistance during January 2023. 39 medical calls, 5 structure fires, 6 grass fires, 1 vehicle fire, 2 motor vehicle accidents, 2 lake rescues, 2 landing zone call, 1 hazmat call, 7 assist calls and 2 mutual-aide calls, totaling 170 volunteer man hours.

CODE ENFORCEMENT/PERMITING

There were 17 permits issued in the month of January. Total collected was \$3926.60.

FIRE INVESTIGATIONS

There was 1 fire investigation done during January. It was ruled accidental. The Fire Marshal's Office responded to 2 Burn Ban Violations, assisted OPD 4 times and Onalaska VFD 6 times.
