Quorum being present, the Mayor continued with the meeting. The purpose of the meeting was to hear from the public, approve the consent agenda minutes, voucher list and accept the financial report, hear reports from the departments, approve the release of Officer Mark Nichols, motion to accept the 2022 Racial Profile report as presented, authorize Chief of Police to enter into Non-Terminal Agreement with the Polk County District Attorney's Office, consideration, discussion and possible action concerning award of an administrative services contract for the preparation of the City's 2023-24 Texas Community Development Block Grant (TxCDBG) CD application and subsequent administrative services contract if funded, consideration, discussion and possible action concerning award of the engineering services contract for the preparation of the County's 2023-2024 Texas Community Development Block Grant (TxCDBG) application and subsequent engineering contract if funded, review and approve Inter-local Agreement between the City of Onalaska and Polk County to acquire the use of certain items of equipment and services of the County in compliance with the requirements of the Texas Election Code and regulations promulgated by the Texas Secretary of State, review and approve Inter-local Agreement between the City of Onalaska and the Onalaska Independent School District for the purpose of conducting a joint election in compliance with the requirements of the Texas Election Code and regulations promulgated by the Texas Secretary of State and announce any other upcoming events.

REPORTS - POLICE DEPARTMENT

Police Department reported that the department traveled 3385 miles during February 2023; 326 Subdivision Patrols, 99 Business Checks, 335 Calls for Service, 16 Arrests, 54 Citations, 79 Warnings, Other Agency Assist 5 times and Assisted OVFD/EMS 6 times, 25 Cases and 22 Warrants served.

FIRE DEPARTMENT

Fire Department reported that the Fire Department responded to 54 calls for assistance during February 2023. 40 medical calls, 3 structure fires, 1 grass fire, 0 vehicle fires, 5 motor vehicle accidents, 0 lake rescues, 2 landing zone calls, 0 hazmat calls, 2 assist calls and 1 mutual-aide call, totaling 136 volunteer man hours.

CODE ENFORCEMENT/PERMITING

There were 11 permits issued in the month of February. Total collected was \$2362.10. Also, Multiple enforcements were started and are in various stages such as warnings, citations, up to Court Summons. Most properties had several violations.

FIRE INVESTIGATIONS

There was 1 fire investigation done during February, with the cause undetermined due to a rekindle and two investigations for burning prohibited items.
