Quorum being present, the Mayor continued with the meeting. The purpose of the meeting was to hear from the public, approve the consent agenda minutes, voucher list and accept the financial report, hear reports from the departments, accept the resignation of Stephen Cook, Telecommunications Operator, authorize the Mayor to sign the City's consent to Assignment Contract between Piney Woods Sanitation and Live Oak Environmental, LLC as required by contract, discuss and take any necessary action on Resolution(s) authorizing the submission of an application, to include the Civil Rights Policies, for the 2023-2024 TxCDBG Community Development Fund competition, discuss and take any necessary action on Resolution(s) authorizing signatories for the 2023-24 application and future grants administered through Texas Department of Agriculture TDA Go grants online and announce any other upcoming events.

#### REPORTS - POLICE DEPARTMENT

Police Department reported that the department traveled 2733 miles during March 2023; 304 Subdivision Patrols, 115 Business Checks, 364 Calls for Service, 11 Arrests, 74 Citations, 137 Warnings, Other Agency Assist 13 times and Assisted OVFD/EMS 7 times, 23 Cases and 17 Warrants served.

#### **FIRE DEPARTMENT**

Fire Department reported that the Fire Department responded to 55 calls for assistance during March 2023. 29 medical calls, 2 structure fires, 9 grass fires, 1 vehicle fire, 1 motor vehicle accident, 4 lake rescues, 2 landing zone calls, 0 hazmat calls, 5 assist calls and 2 mutual-aide calls, totaling 147 volunteer man hours.

#### **CODE ENFORCEMENT/PERMITING**

There were 25 permits issued in the month of March. Total collected was \$9618.80. Also, Multiple enforcements were started and are in various stages such as warnings, citations, up to Court Summons. Most properties had several violations.

#### **FIRE INVESTIGATIONS**

There were 3 fire investigations done during March for illegal burning. 1 citation issued, 1 was unfounded with no prohibited materials observed and 1 pending. Assisted OPD 4 times and OVFD 4 times.
