Quorum being present, the Mayor continued with the meeting. The purpose of the meeting was to hear from the public, approve the consent agenda minutes, voucher list and accept the financial report, hear reports from the departments, review, discuss and take action on Building Regulation Waiver Request submitted by Stephen Brewer and announce any other upcoming events.

PUBLIC FORUM

Mayor Chip Choate – Mayor Choate announced his current medical condition as to eliminate rumors and advised he is taking aggressive actions to get well soon.

CONSENT AGENDA

REPORTS - POLICE DEPARTMENT

Police Department reported that the department traveled 4336 miles during July 2021; 360 Subdivision Patrols, 89 Business Checks, 421 Calls for Service, 7 Felony Arrests, 22 Misdemeanor Arrests, 97 Citations, 68 Warnings, Assisted PCSO 18 times, Assisted DPS 1 time and Assisted OVFD/EMS 13 times, 60 New Cases, 3 Narcotic/DWI Arrests and worked on 70 warrants.

FIRE DEPARTMENT

Fire Department reported that the Fire Department responded to 39 calls for assistance during July 2021. 31 medical calls, 3 structure fires, 0 grass fires, 0 vehicle fires, 2 motor vehicle accidents, 1 lake rescue, 0 landing zone calls, 1 hazmat call, 1 assist call and 0 mutual-aide calls, totaling 67 volunteer man hours.

CODE ENFORCEMENT/PERMITING

<u>Building Inspector-</u> During July 2021, 13 permits were issued. Total permit fees collected were **<u>\$6,424.20</u>** The total added value to the city was **<u>\$1,172,860</u>**.

<u>Code Enforcement</u> – There were a total of 15 code enforcement cases worked.

<u>Fire Investigations</u> — There were no fire investigations within the city. The Fire Marshal's Office assisted OPD 5 times, OVFD 2 times and PCSO 2 times.
