Quorum being present JR Chance's absence was excused, the Mayor Pro Tem continued with the meeting. The purpose of the meeting was to hear from the public, approve the consent agenda minutes, voucher list and accept the financial report, hear reports from the departments, approve re-hire of Officer Simon Prince as full-time Officer with the standard probationary period, approve re-hire of Officer Heather Thomas as full-time Officer with the standard probationary period, approve Rachel Richards as full-time Telecommunications Officer, approve Denise Ross as part-time Telecommunications Officer, approve Jesika Esteves as part-time Telecommunications Officer, review Ordinance 386 and authorize the City Administrator to request proposals for exclusive sanitation services within the City of Onalaska, authorize Gilmore Roofing, LLC to remove existing and install new roofing at the City Hall building for \$23,035.00 as per bid dated November 3, 2021, review and approve Resolution 2021-004 agreement between the City of Onalaska and Polk County Appraisal

District on annual allocation amount due for participation as a taxing entity and announce any other upcoming events.

CONSENT AGENDA

REPORTS - POLICE DEPARTMENT

Police Department reported that the department traveled 3615 miles during October 2021; 267 Subdivision Patrols, 53 Business Checks, 333 Calls for Service, 3 Felony Arrests, 9 Misdemeanor Arrests, 62 Citations, 67 Warnings, Assisted PCSO 12 times, Assisted DPS 3 times and Assisted OVFD/EMS 6 times, 26 Cases, 2 Narcotic/DWI Arrest and worked on 12 warrants worked.

FIRE DEPARTMENT

Fire Department reported that the Fire Department responded to 28 calls for assistance during October 2021. 17 medical calls, 3 structure fires, 2 grass fires, 0 vehicle fires, 3 motor vehicle accidents, 0 lake rescues, 3 landing zone calls, 0 hazmat calls, 0 assist calls and 0 mutual-aide calls, totaling 67 volunteer man hours.

CODE ENFORCEMENT/PERMITING

PERMITTING:

There were 12 permits and 1 animal license issued in October. There were 16 inspections done for the month of October. The total added value to the city is \$542,565.00. The total permit fees collected was \$3,472.80

CODE ENFORCEMENT:

There were 8 ordinance violation cases started with 10-day compliance warnings issued. 2 came into compliance, 6 of the properties are a work in progress and 2 have had no change with enforcement moving to the next stage. There was also 12 follow up investigations performed throughout the month.

FIRE INVESTIGATIONS:

There was 1 fire investigation within the city limits for October.

OTHER ACTIVITIES

The Onalaska Fire Marshal's Office assisted Onalaska PD 4 times and assisted Onalaska VFD 8 times with multiple types of calls ranging from fire suppression, medical calls and landing zones.
