Quorum being present, the Mayor Pro Tem continued with the meeting. The purpose of the meeting was to hear from the public, approve the consent agenda minutes, voucher list and accept the financial report, hear reports from the departments, review and approve Police Department Policy 2.8 Use of social media, review and approve Ordinance #419 Amending Ordinance #417 Ordering the General Election on May 7, 2022, review and approve Ordinance #420 Amending Ordinance #418 Ordering the Special Called Election on May 7, 2022 and announce any other upcoming events.

Dennis Hodge, Pastor of Wildwood Gospel Church, opened the meeting with a prayer and Paul Laverty led the pledge to the American and Texas Flags.

PRESENTATION OF ONALASKA FIREMEN OF THE YEAR AND MOST CALLS PLAQUES

Fire Chief J. C. Stutts presented Firemen of the Year Plaques to Dennis Hodge and to the family of Dennis "Bubba" Key, Jr. recognizing their outstanding service to the Onalaska Fire Department.

Chief Stutts presented "Most Calls" plaque to Raymond Grace and thanked him for his service.

REPORTS - POLICE DEPARTMENT

Police Department reported that the department traveled 3634 miles during January 2022; 349 Subdivision Patrols, 102 Business Checks, 297 Calls for Service, 12 Felony Arrests, 52 Misdemeanor Arrests, 103 Citations, 134 Warnings, Assisted PCSO 16 times, Assisted DPS 0 times and Assisted OVFD/EMS 9 times, 45 Cases, 1 Narcotic/DWI Arrest and worked on 3 warrants worked.

FIRE DEPARTMENT

Fire Department reported that the Fire Department responded to 48 calls for assistance during January 2022. 20 medical calls, 8 structure fires, 4 grass fires, 0 vehicle fires, 6 motor vehicle accidents, 2 lake rescues, 4 landing zone calls, 1 hazmat call, 4 assist calls and 1 mutual-aide call, totaling 95 volunteer man hours.

CODE ENFORCEMENT/PERMITING

There were 9 building permits issued in the month of January. Total collected was \$840.00.

There were 7 citations issued in the month of January by Code Enforcement for Unwholesome conditions, unsafe and/or dangerous buildings.

FIRE INVESTIGATIONS

There was one investigation for a suspicious fire and circumstances. Upon inspection of the burned area, it was determined to have been an old, dilapidated structure (non-dwelling). Due to the location of the fire, there was no evidence located or recovered to indicate it was intentionally set to destroy the structure. Cause Ruled Undetermined.

Librarian reported for the month of January: Current borrowers 1741. CITY ADMINISTRATOR WILL REPORT ON STREET REPAIR AND MAINTENANCE

Chelsea Street is complete with the added materials and road work as planned. Residents seem very pleased. We are waiting on the weather to add material to Holmes Road but was bladed this morning along with Hodge Bottom. Hanson Road may be bladed today or tomorrow depending on time.

The 2020 TDA project construction is underway in Oakridge Subdivision. Waiting on the change order (shoulder up the road edges) approval from TDA, however expect completion within 30 days. I was given information today that asphalting may start as early as Thursday. Once complete we will be able to move forward on additional work needed on Pine Grove and Sycamore.

TXDOT advised that they will be in the area tomorrow and will fix the potholes at the end on FM 3459 and Hwy 190 and at Chelsea Lane and Hwy 190.

Upon request Commissioner Vincent evaluated pot holes on Town and Plaza Streets and they both have been added to the repair list for later this week or early next week. We are seeking regular assistance to clean up and around the city sidewalks.

Smith Drive – I asked Commissioner Vincent to take a look and advise. His suggestion is add materials (Rock) with estimated cost of \$3,000.00.

Last, if anyone has a road complaint, please let me know so that it can be documented and evaluated
