REPORTS - POLICE DEPARTMENT

Police Department reported that the department traveled 2879 miles during February 2022; 331 Subdivision Patrols, 106 Business Checks, 328 Calls for Service, 14 Felony Arrests, 5 Misdemeanor Arrests, 100 Citations, 123 Warnings, Assisted PCSO 11 times, Assisted DPS 0 times and Assisted OVFD/EMS 12 times, 45 Cases, 7 Narcotic/DWI Arrest and worked on 15 warrants worked.

FIRE DEPARTMENT

Fire Department reported that the Fire Department responded to 39 calls for assistance during February 2022. 24 medical calls, 4 structure fires, 5 grass fires, 0 vehicle fires, 3 motor vehicle accidents, 0 lake rescues, 1 landing zone calls, 0 hazmat calls, 0 assist calls and 0 mutual-aide calls, totaling 91 volunteer man hours.

CODE ENFORCEMENT/PERMITING

There were 13 building permits issued in the month of February. Total collected was \$9,064.20.

There were 4 citations issued in the month of February by Code Enforcement for Unwholesome conditions, unsafe and/or dangerous buildings.

FIRE INVESTIGATIONS

There were two fire investigations for illegal burns where no evidence was observed of anything other than brush and leaves being burned and was ruled unfounded.
