Quorum being present, the Mayor continued with the meeting. The purpose of the meeting was to hear from the public, approve the consent agenda minutes, voucher list and accept the financial report, hear reports from the departments, review and approve personnel action requests, review and approve Inter-local Agreement between the City of Onalaska and Polk County for evaluating septic systems, authorize the Mayor and City Administrator to sign the Texas Municipal Retirement System City Portal Use Agreement appointing Angela Stutts, City Administrator to serve as the City Portal Administrator and announce any other upcoming events.

PLEDGE & PRAYER

Mayor Chip Choate opened the meeting with a prayer and Shirley Gilmore led the pledge to the American and Texas Flags.

PUBLIC FORUM

Charles Collins spoke regarding Kickapoo Creek Drive and requested council review Ordinance 249.

M. Scott Williams spoke regarding Kickapoo Creek Drive repair and maintenance issues.

CONSENT AGENDA

It was moved by Shirley Gilmore and a second was made by James Arnett to accept and approve items listed on the consent agenda as presented.

REPORTS - POLICE DEPARTMENT

Police Department reported that the department traveled 4455 miles during October 2019; responded to 1772 non-dispatched calls; 247 dispatched calls; 15 officer assists, and assisted the fire department 6 times. Besides all of this, 168 citations, 31 warnings. Worked 52 cases, 61 misdemeanor arrests and 6 felony arrest were made.

FIRE DEPARTMENT

Fire Department reported that the Fire Department responded to 36 calls for assistance during October 2019. 21 medical calls, 2 structure fire, 2 grass fire, 0 vehicle fires, 1 motor vehicle accident, 1 lake rescues, 2 landing zones, 0 hazmat calls, 7 assist calls and 0 mutual-aide calls, totaling 37 volunteer man hours.

CODE ENFORCEMENT/PERMITING

<u>Building Inspector</u>- During October 2019, 16 permits were issued. Total permit fees collected were **\$2,730.40**. The total added value to the city was **\$354,944**.

<u>Code Enforcement</u> – During October 2019 there were 21 citations issued for City Ordinance Violations and 10 for Animal Ordinance Violations.

Fire Investigations - There were 2 fire investigations in October 2019.
