The purpose of the meeting was to hear from the public, approve the consent agenda minutes, voucher list and accept the financial report, hear reports from the departments, presentation of Christmas Decorating Certificates, presentation of City Audit conducted by Belt Harris Pechacek for fiscal year ending September 30, 2019 with action to accept, review and approve recruitment of Reserve Police Officer Jacob Resch, accept the Racial Profile Report for 2019 as presented, review and approve Resolution 20-001 amended Employee Vacation Policy, review and approve Resolution 20-002 Establishing policy regarding civilian riders to be included in the Police Department Policies and Procedures manual, review and approve Resolution 20-003 Creating a Part-time/Temporary Police Officer Position for the purpose of working Warrants, Code Enforcement and filing vacant shifts, review and approve Resolution 20-004 authorizing the purchase of a 2020 Tahoe with

### **CONSENT AGENDA**

#### **REPORTS - POLICE DEPARTMENT**

Police Department reported that the department traveled 6628 miles during November 2019; responded to 1566 non-dispatched calls; 283 dispatched calls; 27 officer assists, and assisted the fire department 8 times. Besides all of this, 184 citations, 33 warnings. Worked 58 cases, 34 misdemeanor arrests and 22 felony arrest were made.

Police Department reported that the department traveled 6763 miles during December 2019; responded to 1529 non-dispatched calls; 189 dispatched calls; 23 officer assists, and assisted the fire department 4 times. Besides all of this, 184 citations, 57 warnings. Worked 11 cases, 46 misdemeanor arrests and 12 felony arrest were made.

#### FIRE DEPARTMENT

Fire Department reported that the Fire Department responded to 33 calls for assistance during November 2019. 26 medical calls, 1 structure fire, 1 grass fire, 0 vehicle fires, 2 motor vehicle accidents, 0 lake rescues, 0 landing zones, 0 hazmat calls, 3 assist calls and 0 mutual-aide calls, totaling 51 volunteer man hours.

Fire Department reported that the Fire Department responded to 32 calls for assistance during December 2019. 24 medical calls, 0 structure fires, 1 grass fire, 1 vehicle fire, 0 motor vehicle accidents, 0 lake rescues, 1 landing zone, 0 hazmat calls, 5 assist calls and 0 mutual-aide calls, totaling 195 volunteer man hours.

#### **CODE ENFORCEMENT/PERMITING**

**<u>Building Inspector</u>**- During November 2019, 10 permits were issued. Total permit fees collected were **\$2,579.20**. The total added value to the city was **\$260,200**.

During December 2019, 8 permits were issued. Total permit fees collected were \$1,160.80. The total added value to the city was \$125,350.

<u>Code Enforcement</u> – During November 2019 there were 73 citations issued for City Ordinance Violations and 7 for Animal Ordinance Violations.

<u>Code Enforcement</u> – During December 2019 there were 6 citations issued for City Ordinance Violations.

<u>Fire Investigations</u> – There were 0 fire investigations in November 2019 and 1 in December which at this time is ongoing.
