Quorum being present, the Mayor continued with the meeting. The purpose of the meeting was to hear from the public, hear presentation by census representative, approve the consent agenda minutes, voucher list and accept the financial report, hear reports from the departments, review and approve personnel action requests, review and approve Resolution 20-007 Trial Preparation Procedures, review and approve Resolution 20-008 creating a Part-time Maintenance Position, review and approve Ordinance 395 Manufactured Home/Modular Home Ordinance, review and approve Ordinance 396 amending Ordinance 373 Building Regulations, review and approve Ordinance 397 Permit Fee Schedule, Executive Session as authorized by Texas Government Code Section 551.074 Personnel Matters and announce any other upcoming events.

REPORTS - POLICE DEPARTMENT

Police Department reported that the department traveled 5414 miles during February 2020; responded to 1246 non-dispatched calls; 195 dispatched calls; 17 officer assists, and assisted the fire department 3 times. Besides all of this, 141 citations, 59 warnings. Worked 54 cases, 33 misdemeanor arrests and 5 felony arrest were made.

FIRE DEPARTMENT

Fire Department reported that the Fire Department responded to 28 calls for assistance during February 2020. 19 medical calls, 1 structure fire, 1 grass fire, 0 vehicle fires, 0 motor vehicle accidents, 0 lake rescues, 2 landing zones, 0 hazmat calls, 4 assist calls and 1 mutual-aide call, totaling 34 volunteer man hours.

CODE ENFORCEMENT/PERMITING

<u>Building Inspector</u>- During February 2020, 16 permits were issued. Total permit fees collected were <u>\$4259</u>. The total added value to the city was <u>\$334,557</u>.

<u>Code Enforcement</u> – During February 2020 there were 7 warrants issued on repeat offenders. One property brought into compliance with a total of 10 cases worked.

<u>Fire Investigations</u> – There was no fire investigations in February.
