Quorum being present, the Mayor continued with the meeting. The purpose of the meeting was to hear from the public, approve the consent agenda minutes, voucher list and accept the financial report, hear reports from the departments, review and approve personnel action requests, review and approve Ordinance 400 adopting the budget for fiscal year 2020-2021 (October 1, 2020 -September 30, 2021) Budget, review and approve Ordinance 401 levying ad valorem taxes for the use and support of the municipal government for the City of Onalaska for the 2020-2021 fiscal year, providing for a portion of each levy for specific purposes and providing for a tax rate of \$0.00 per \$100.00 of taxable valuation, review and approve Resolution 20-014 Public Funds Investment Policy, review and consider Burn Ban and announce any other upcoming events.

REPORTS - POLICE DEPARTMENT

Police Department reported that the department traveled 3949 miles during August 2020; responded to 1392 non-dispatched calls; 316 dispatched calls; 31 officer assists, and assisted the fire department 8 times. Besides all of this, 83 citations, 81 warnings. Opened 52 new cases, 14 misdemeanor arrests and 7 felony arrest were made.

FIRE DEPARTMENT

Fire Department reported that the Fire Department responded to 22 calls for assistance during August 2020. 12 medical calls, 0 structure fires, 2 grass fires, 1 vehicle fire, 5 motor vehicle accidents, 1 lake rescue, 1 landing zone, 0 hazmat calls, 0 assist calls and 0 mutual-aide calls, totaling 40 volunteer man hours.

CODE ENFORCEMENT/PERMITING

Building Inspector - During August 2020, 15 permits were issued. Total permit fees collected were \$3304.80 The total added value to the city was \$530,400.

Code Enforcement - There were 66 warnings issued for various City Ordinance violations for unwholesome conditions and Animal Ordinance violations.

Fire Investigations - There was one fire investigation ongoing from July that was determined accidental and case closed. There were no new investigations for August.
